THE PHRASE OF THE MONTH

The guys are on edge: since 12th June, the judge of the Administrative Court decided to evacuate, every morning, they expect to see the police arrive and to be sent back on the roads...

But what does the police do? Yesterday she shot a kid, and he died. In Iraq, it's every day...

A WORD FROM THE PRESIDENT

Our REPUBLIQUE and its POLICE!

From the early 2000's SALAM, a daily witness on the ground, tried to alert the authorities. Ongoing harassment Overt physical abuse Destruction of camps Substitutions of private items Confiscation of shoes Excessive police custody Etc. And violence even more visible Inappropriate use of tear gas Systematic flash ball shots

SALAM, a daily witness from the field, tried to alert the authorities. These systematic abuses reflect a misuse of the role of police. The failure to listen to the authorities encourages the abandoning of ethics. Protective ethics for both the citizen and the police officer, Putting all our policemen on the "blacklist", for a few crooked officials! SALAM, a daily witness from the field, tried to alert the authorities. In recent years: "Yellow Vest" protests Actions against pension reform Interventions in "neighbourhoods" The journalists' cameras revealed the attitudes we were denouncing.

Successive rulers bear a heavy responsibility. Not wanting to hear anything. Not wanting to see anything. Not even the cries of alarm from some police unions. Simply, systematically they praise our police forces.

Our police deserve better.

Our police are the fundamental tool for a well-functioning democracy. It is still necessary that our leaders show courage, And do not let the police force be dirty for individual slippages. Or inappropriate orders or even as wrong as illegal! It is URGENT that our leaders get to work on the subject. Otherwise, social peace will not be sustainable. All citizens are ready to find a peaceful Republic. All citizens are legalistic. All citizens want ethics, the strong DNA of our police officers.

Then we might not experience such riots again. Likely to cause a lot of deaths! SALAM knows that only PEACE IS THE SOLUTION!

EVENTS OF THE MONTH

LAST MINUTE: ONE MORE DEATH, ONE TOO MANY.

On 5th July, the "Death Group" informs us: "Yesterday a person of Sudanese origin was found unconscious on the highway. Sadly, she died last night in Calais hospital. >

The shipwreck in the Ionian Sea on the night of June 13 to 14 had already been enough to land us: About 500 dead even if "only" 79 bodies were found...

With us, everyone is there with the certainty of moving quickly to England.

And indeed, more or less easily, more or less quickly, they pass, also at the risk of their lives...

On June 16, we were informed of the successful crossing of a family (from the Loon-Plage camp) with six children.

It was their 17th attempt...

Summer has finally arrived and the crossings are sometimes easier, between periods of strong winds that stop any attempt.

The Home Office publishes 616 arrivals in the United Kingdom on twelve boats on the night of 11 to 12 June. That means 51 per boat on average.

Who among us would leave under these conditions?

What if we let them do it, without daring to talk to them "quietly" but at least without hindrance?

However, the police are present everywhere to prevent boarding:-

- on the places of departure (beaches, dunes...) to deter,

- in Calais railway station now, to discourage volunteers even before an attempt (photo of June 23).

On June 3, for example, about forty Sudanese were searched when they got off the train from Amiens under the eyes of one of our volunteers. These are people returning from the June 1 evacuation, further proof of the forced nature of many of these bus departures.





On June 9, five vehicles of the Railway Security and the National Police were there, at the station. Groups of guys are stopped, but white people go unchecked. This segregation is illegal.... People are separated according to nationality (Afghans, Iranians):

People are separated according to nationality (Afghans, Iranians): about thirty people.

All end up passing except the Turks.

Ten people were arrested: they left in two "PAF" vans.

Some are driven back to the train by the police. (picture to the left).

The HRO is escorted outside

These are examples.

And we have been going around in circles for months, for years: it is forbidden to leave, but above all we must not stay there.

It is the refusal of "fixing bridges", repeated tirelessly. Concretely, this is what justifies the evacuations of the camps every other day in Calais.

They are not intended to protect people:

June 2: Rue des Huttes, two Afghan families (17 people) are not accepted on buses leaving for CAES (Sheltering Centres).

The same day, on the BMX site, the arrested police officer suddenly became aware of it:

What are you going to do with the people inside?" asks the HRO (Human Rights Observers).

We're going to cajole them... Please, I'm going to ask you to step back...

You just have to discourage people from being there...

CALAIS:

Evacuations hardened during the month.

A timetable (every other morning) seems established. But on June 7, it was again in the afternoon that the CRS arrived to move the exiles and pick up the belongings that remain on the camps. Since then, the HRO (Human Rights Observers) must also watch in the afternoon if they have not seen anything in the morning. On Friday the 16th, the convoy left much later than usual and was not spotted (except of course by the exiles on the ground who brought it back later...)

It is as if there was a game of hide and seek for this evacuation work to be done discreetly. For a long time, we have been asking the question: "What is their need to hide so that the associations cannot see what the police are doing?"

The perimeters of "security" are a pretext: no danger, no evidence to seek: citizens are allowed to pass, to cross the areas of intervention of the police...



On June 7, helmets and shields reappeared. Have concerns reappeared in the ranks of our "peacekeepers"? We can rather fear that they are trying to scare ... Because this police deployment is disproportionate:

The equipment of the Police becomes impressive again: in May, they wore only skullcaps,





In addition to the LBDs often present at the surveillance of security perimeters... ... On June 13, rue de Judea, the HRO spotted a large rifle, which according to the CRS was not a LBD. An assault rifle ?



The behaviors are very brutal: on June 9 all the people present, are lined up against a wall in the City Center; We had never seen that before...



Forcing people to move their tents every other day by carrying or dragging them, is already terrible violence...



... Especially since the tents are moved further and further away from the campsite.

The rule is the same since the hunger strike and Leschi mediation of November 2021: exiles have time to pick up their belongings (including tents and tarpaulins), that which is abandoned (this includes the belongings of all those who are absent at that time) is picked up.



Many people, returning for an attempt at a crossing, sleep on the floor in the city centre: you cannot both risk on being the water and keep an eye on all your belongings. Those who come back have nothing... And on June 7, the HRO (Human Rights Observers) heard a riot police saying: "There's no one there, so you picking up stuff !" when it was the police who got people out.

Two backpacks can be picked up by one person, but another cannot get their phone back.



In addition, the destruction of makeshift shelters is systematic: they allow a little storage of equipment, therefore comfort. All are forced to move by the minute. In this photo from 15th June, we see an exile brushing his teeth and a policeman forcing him to move, very urgently.



A very large dismantling took place on June 1 in the sectors of Marck (the place called "La **Turquerie**") and the rue de Judée. Everyone had been expecting it for weeks: it was the most populated site and had not yet been evacuated.

At least 14 CRS vans are visible from HRO observation points, and at least four PAF vans.

The police surround people to make them go to buses. (At least six left, loaded.)

The HRO sees about twenty exiles who have managed to escape by the railway and under the fences, and others hidden in the bushes.

But a CRS says, in the afternoon, that only the volunteers left by bus...

It has been a long time since bus departures were forced and forced again..

In May 2022 (a year ago) Jean-Claude Lenoir, president of Salam, had called the sub-prefecture on this subject:

He was told that the official approach was as follows: when there is dismantling, people are directed to the public road (pavement, road, car parks ...). There, they are told that they are free.

Then, they can go either to the CAES or to the police station (for control of residence permits). This is very hypocritical, but it is the current rule.

Our friends have often told us: those who do not agree to board the buses are taken to the police station. The choice is quickly made!

On June 1st, in the early afternoon, there were no more exiles left at La Turquerie, and (rental) vans for collecting equipment arrived,





In addition to very large skips... ... to complement the usual van and small dump truck.





The tents are emptied and collected. The term "cleaning" is unrealistic... A police officer says the tents will be "reconditioned and made available to the Resource Centre". It's hard to believe that some can survive the way they're picked up!





On Friday, June 2, the operation continues: not everything was removed on Thursday.

Salam meets people who were chased out of the Turquerie camp the day before, who have nothing left and who have not had places on a bus.

They are hungry: we have to go back to the local area to prepare tea and collect bread and we have to come back at the end of the day to distribute duvets and the last few tents we had left. At that moment there is bread that has become hard as wood in a vehicle; Boys throw themselves on each other like misery on the world. On the 3rd, at the Turquerie, many came back and slept on the floor with nothing covering them... The Salam team has at least 150 people.



On the 4th, the pickup continues... ... and the land was ploughed on Judea Street, to prevent any resettlement, after the dismantling on Thursday.



LOON-PLAGE :

When will the camp set up on the Loon-Plage travellers' area be evacuated?

In the May issue of this newsletter, we announced the display, at the entrance of the Travellers' camp, of a request for interim useful measures: the Administrative Court then has one week to decide whether or not to evacuate an illegally occupied place. This request, dated 25th May, posted in the afternoon the same day, announces the judgment for 31st May (it is important to note that May 27th/28th and 29th are the Whitsun weekend...)

A group of one hundred caravans of travellers is expected, says the CUD, for 25th June.

The hearing did take place on 31st May. The court decision fell on Monday, 12th June . Lionel Crusoe, lawyer for the occupants of the land, writes to us: "As was unfortunately to be expected, the administrative court of Lille, in view of the elements in the last place presented by the urban community, ordered the occupants to leave the premises." ...

We knew that this occupation could not be definitive... And we have nothing against Travellers. We still refuse to oppose precariousness. We were not asking that the evacuation do not take place. We ask that the exiles are not simply be sent back on the roads but moved to a more dignified place. We are not asking for a "4-star" campsite, we are just asking for a place with a water point, toilets, and a rubbish dumpster is regularly emptied.



Because those who have now set up their tents, where will they be able to go? No one knows...

By way of being pushed back always a little further, they no longer have many solutions...

On Monday, 19th June, tense, tired of waiting day by day for a big final evacuation, a good part of them moved to the other side of the D601 road, hoping to find a little respite. But the next day the movement is in the opposite direction... Salam, like other associations, has trouble knowing where to distribute... We all do not understand on the 22nd that nothing is yet done to install water and electricity for the hundred caravans expected for June 25th...

It seems that this arrival is delayed by a week, if we believe the "Voice of the North" of Thursday, 22nd June, which we discover on the 25th.

Our lawyer, Lionel Crusoe, replied the next day: "This new element unfortunately does not make it possible to render the order null and void.

It can only lead to the prefect not immediately granting the assistance of the police for the execution of the expulsion measure.

In other words, the occupants could benefit, in fact, from a small reprieve... » That's apparently what's going on...

Our friends have been there since 4th/5th May: it is a pleasant period of respite even if the camp remains terribly precarious (without water point except the fire hydrant and without toilets)

A SMALL TRIBUTE TO CONCLUDE, TO THE YOUNG PEOPLE OF THE HRO, to the young people because their work requires a good physical shape (no retirees among them!)



It is necessary to hold the blow of the awakenings in the early morning to be in observation from dawn:

First remark of the day on Whatsapp: June 1st in Calais, 6:17 am and the 28th in Loon-Plage, 6:39 am.

They do some "security checks" on bikes, to save the vehicle, like on the morning of May 21.

And the conditions of observation are often implausible:

- from far away through a fence topped with razor blade barbed wire, even if these barbed wires draw hearts...



- through the "keyhole", in fact through vegetation or by imagining tricks to see what we do not want them to see (we continue to wonder what they may have to hide...)





- and from improbable and acrobatic observation posts.

SHAME

How much longer are we going to accept that children, women and men drown while trying, at any cost, to flee hunger, misery and violence to take refuge in Europe? How can we, looking at each other without quivering in a mirror every morning, insist on closing the borders of Europe twice, knowing that this lock pushes migrants precisely to bypass the obstacle and to take the most perilous routes? How can we decently decide to reduce the means of rescue at sea thinking that it will deter migrants from attempting the crossing? How can we imagine depriving the other the stranger of a better life when we are all the products of past migrations and our ancestors have mostly fought the same battles? How can we still prevent women and men from coming to work on our territory when we are constantly lamenting the lack of staff in hospitals, nurseries, schools, transport companies, restaurants, bakeries and so on?


The tragedy of Peloponnese is unspeakable; hundreds of people on a simple fishing boat, who had been asked to remove their life jackets in order to pack them down further, gone with fear in the stomach from Syria, Afghanistan and Libya, with no possible alternative. When we think back to the cries of outrage after the tragedy of Annecy, last week, to the Zemmour and other Ciotti who hastened to make a particular case a generality to better distil fear and prosper their little business of hatred of foreigners, we are ashamed for them. It is high time to change our logic, and if not for humanitarian reasons, at least for a matter of common sense: our policy of non-reception migration does not work. It does not deter those who leave for Europe from testing their luck. It kills them.

A SUCCESS IN COURT.

A real victory in Ouistreham.

Salam was not involved in this dispute since we do not intervene in Normandy. But the fight was the same as here in Calais. So we are very happy for the exiles who survive there and also because it can set a precedent for our camps.

Indeed, the judge of the Administrative Court of Caen, on 2^{nd} June, ordered the municipality of Ouistreham and the prefecture of Calvados to "create, in the immediate vicinity of the migrant camp, water points and latrines, as well as a device of access to showers according to modalities providing dedicated slots for vulnerable people" in connection with the applicant associations and within eight days.




- Sophie, from Shefield University, who is doing research on borders, in relation to art, and who spent almost two weeks with us. We very much hope to see her again.

TENTS AND TARPAULINS!

From dismantling to dismantling, the tents are removed at both sites and we are unable to replace them. Many people sleep with nothing protecting them, in all weathers.

But we hesitate to suggest you buy tents: the life expectancy of a tent is a few days...

On the other hand, tarpaulins, pieces of 3 m by 3m (or 2.50m by 3m), cost much less and allow an honest man to spend a night under the shelter.

Otherwise, the most pressing needs on both sites:

BLANKETS (DUVETS, SLEEPING BAGS).

hygiene products (shampoo, shower gel, deodorant, sunscreen, etc.), especially razors, towels,

men's clothing from XS to XL: underpants, long underpants and thermal leggings and thermal sweaters, socks, jogging pants, jeans, shorts, t-shirts, SHOES for men: trainers or light hiking shoes (sizes 40 to 46), sandles, caps.

backpacks, lamps and batteries, water packs, bags (small backpacks, garbage bags, freezer bags, tote bags and plastic bags))

Food for Calais:

Milk tea and sugar, soluble coffee, cans of sardines and cans of tuna, cream Cheese, dried fruits, Power banks/ batteries.

To drop off your donations, RDV 13 rue des Fontinettes, and call 06 83 16 31 61.

And for Grande-Synthe:

Especially canned vegetables of all kinds (we have been receiving much less fresh goods for some time), bags of pulses, spices,
