EVENTS OF THE MONTH

LAST MINUTE:

On the morning of 3rd March, we learned that a 7-year-old girl had just drowned: a boat had been wrecked on the Aa canal, near Watten.

That it's a little girl is terrible, of course, but no more so than if it was 20-year-old. The pain of all lost loved ones is the same.

On the other hand, it was a little girl who was taken on board with her parents, her mother who was pregnant with a fifth child, and three other children. And this should challenge us: it is proof that these people only leave driven by extreme necessity, that they did not launch themselves on a whim, to see if the grass was greener on the other side of the channel...

And today as ever, we know that this is not the last time that it will happen. This family will be discharged from hospital, and they will be required to return to the muddy camp site without toilets and a distance from the nearest available tap water facility... And what are they going to do to get out of this dire situation? All they can do, is to get back on their feet in search of a new passage to the United Kingdom, with a tenfold increase in anxiety but with the same determination...

ONE DEAD AND TWO MISSING IN AN ATTEMPT TO CROSS TO THE UNITED KINGDOM BY SEA...

An announcement from the "Voix du Nord" (website) on 28th February...

How can we **not** say that this means three deaths?...

The usual commemoration took place at Richelieu Park at 6:30 p.m. on 29th February.

Philippe Demeestère, the day after the shipwreck, reacted in sobering terms:

"Hello! Anger, solidarity: yes. But what else?

How can we not leave it at that? This is my question. Yours? Ours?

At the moment, a memory that crosses my mind is that of the "Hill of Crosses", through which Lithuanians, under Soviet occupation, remembered the victims of repression. Regularly, they were broken down; Regularly, they were put back in place by the local population. Imagine.

How can we just not stop here? In the past, there have already been initiatives which, in the wake of our "group feelings", have led us for example, to the City Hall. In the long run, what can we imagine that will allow us to overcome our frustrations after attending a burial and not taking on the thoughts of defeat? Questions. Still questions, ... not to be forgotten. Obstinately.

ALREADY ONE SHOT DEAD ON THE LOON-PLAGE CAMP DURING THE NIGHT OF 3rd/4th FEBRUARY:

Another drama of precariousness: an argument that goes wrong...

His body, as well as that of another injured man, had been placed on the side of the A16 "to facilitate their care".

We already pointed this out in the last issue of this newsletter. We cannot get used to it...



ON 6th FEBRUARY, A COMMEMORATION EVENT

WAS HELD in memory of all those dead and missing on the border: the meeting was at 6 p.m. at Richelieu Park.

- Ten years ago, on 6th February 2014, dozens of people drowned while trying to swim to the Spanish enclave of Ceuta from neighbouring Morocco.
 - More than 200 people had taken to the water. The Spanish guards turned them back, the Moroccan military did not rescue them. Every year since, an appeal has been made for this anniversary to remember them and to put an end to these murderous policies.

A GLOOMY MONTH, SAD LIKE A WINTER THAT NEVER ENDS.

It's cold, but not cold enough for "Cold Weather" shelters to be opened. It rained a lot, but not enough for "bad weather" aid to be offered to the exiles.

The cold water and the bitter wind would discourage the most daring.

However, as soon as the so-called "weather window" opens, the camps are emptied... The D 601 (old road from Calais to Grande-Synthe) is covered with people in motion (the photo was taken on 27th February).



People are flocking to the coast. The police are also in a hurry, to prevent the departure of those who do not want to be welcomed...

On 17th February, the young men told of the impossible access to the sea the night before and, also the day before, so numerous were the police that blocked them. Jean-Claude Lenoir (president of Salam) describes the crowd of exiles, in the city of Calais, with Vigipirate at the train station, and the many arrests behind the PASS of people who were released the next morning...

Between 8th and 28th February, the UK Home Office recorded 920 arrivals on 19 inflatable boats: an average of between 48 and 49 people per boat.

But the missed crossings are much more numerous:

On 2nd February, the Salam team met a group of 30 to 35 men on Rue de Huttes who were carrying numbered garbage bags (a sign that they had been dressed after a failure that had left them soaking wet on the sand. The garbage bags contain their wet belongings). The biggest number is 59, so there were a lot more of them than they were there at this time...

They are there because they hope to be sheltered in a CAES for a few hours or a few days: the rue des Huttes is the departure point for the shuttles. But that morning, there was only one minibus. The centres are full. And it's Friday. There won't be any more until Monday...

Behind the PASS, the faces are grey with fatigue.

Situations of distress are multiplying families are there, a father comes to get Salam's breakfast with a little one who is barely walking, there are three other families together with a dozen children, the oldest of whom is about ten years old.

In BMX, there are more and more very young women, and so young: they are not 20 years old... We even saw one, on 20th February, with braces! We can't imagine what these young girls must have endured on the road.

On 17th February, a few hundred people crowded the rue des Huttes, but the bus arrived and only picked up families. No one is asking that we leave the children outside, of course. But no single man could sleep outside in February and we should at least, stop the dismantling of tents and provide time to open places in the Reception Centres, instead of repeating that we do not understand that these people do not accept shelter and instead of being surprised that they want so much to leave France for England ... On 9th February, a Human Rights Observers (HRO) video taken behind the PASS, a police officer was stunned to say, authoritatively:

"If there is one who wants to be sheltered, I will take care of him (...)

I'm not telling you how he'll be taken care of, I'm telling you that we're taking care of him...

And he'll go to a shelter. »

This is contrary to everything we have heard repeated elsewhere, as access to the Reception Centres is only by the shuttles that leave in the morning from the rue des Huttes... How can a representative of the state boast of being above the regulations?

Missed departures explain the increasing number of people at our food distribution locations. Between Friday 9th and Tuesday 13th February, the number of hot drinks needed for breakfast in Calais had

to be increased by 30 litres. On the 14th, we had to go back twice, to buy bread (820 people to feed that morning).

Also on 21st February, we had to buy more bread on the road and increase the quantity of hot drinks by 20 litres (920 breakfasts that morning).

In January, we averaged 563 per day...

DISMANTLING.

The camps on the Dunkirk side have been spared since 30th November (apart from the corner of the shops on 28th December and 4th January). Three months without evacuation is remarkable...

Of course, we have been very attentive since the installation of the garbage truck on the Mardyck side of the D601 on 20th December and since the installation of the water point on 23rd December in the same area: this seems to indicate an upcoming move (therefore a big dismantling) to this area forcibly evacuated last year at the beginning of May 2023...

It's just a rumour but it persists, and it swells...

It is swelling even more as the gates are multiplying on the Loon-Plage side to close the industrial zone, as we had already said in the previous issue of this newsletter, by road and by the path under the bridges...







... and also on both sides of the tracks:

On Thursday, 22nd February, we read in the WhatsApp " Human Rights Observers " of Grande-Synthe that another association had spoken with one of the people in charge of the work on the gates. They finished automating the doors and built guard posts next to the gates, where there would be 24-hour security.

The workers said they are waiting for the green light from the prefecture to move the motocross/plain people and that it will happen in the next few days. It's been two months that we feel this move/dismantling coming... It will surely happen eventually...

In the meantime, we continue to distribute at the end of the rue des Prés février, and the ground is more and more muddy and difficult to navigate.

On the Calais side, breaches of the rule of evacuations every 48 hours were a little more frequent: one in January (nothing between the 20th and 23rd), three in February (nothing between the 2nd and 5th, between the 15th and 18th and between the 20th and 23rd).

It's a welcome respite for our friends, but we've been told so many times that the 48-hour deadline is unavoidable because of the flagrance deadline, that we don't understand this elastic application of the law: if a 48-hour deadline cannot be exceeded for the evacuation of illegally occupied land, it must be every time! Or, on the 3rd day, we should no longer be able to evacuate...

Undoubtedly, as the great La Fontaine said, "the reason of the strongest is always the best... »



No change in the flow of evacuation operations for years: The forces of law and order are extremely numerous, and often heavily armed.

(On 29th February at BMX, this view of the HRO coincidentally brings together the gaseous, the baton and the shields!)

On 29th February, in Marck, the HRO heard riot police say: "We're going to gas them!"

Almost always, a so-called "security" perimeter (but who does it protect from what?) keeps the HRO (Human Rights Observers) away from operations and prevents observations... On 13th February, however, at La Fermette, a small channel separated the HRO from the evacuation... This annoys the police because the visibility is quite good...



The tents were moved: the exiles had no choice, they had to remove them from their place to wait a little further.

Sometimes, contrary to the right acquired following the hunger strike in the autumn of 2021, they have to abandon their tent and take only their personal belongings...





Tents are then seized, as are tents whose owner is not present at the time of evacuation.





The most frequently seized items are tents, but also pallets.



The importance of tents does not need to be demonstrated, pallets are valuable because they are used to make fires for warmth and cooking, but also, they serve as a base to insulate tents from the mud.

On 23rd February, at La Fermette, we saw "cleaning" staff moving tents (that's the rule) but to pick up the pallets that were underneath.

And that's scandalous: when the owner of the tent brings it back to its place, how is he going to make sure it doesn't get bathed in mud or puddles?

Well, he can only sleep in the water...

The collection of the material is done in two vehicles, by personnel who accompany the Police. It's almost always a van and a small dump truck. Since 18th February, we've seen a really big van appear!





Arrests are frequent.

They are often accompanied by a body search, with the "nose against the wall"...

These scenes take place too far away from the HRO (Human Rights Observers) for images from their videos to be usable for us...

The police say "arrest for the control of residence permits", except that if they had "residence permits", the exiles would not be in these poverty camps looking for an improbable murderous passage to the United Kingdom.

When the operations are over, the exiles have the right to set up their camp again, and this is where all the hypocrisy of these operations comes out: they resettle when the Forces of Order leave, but almost every time, they do not wait until they are no longer there to discreetly put themselves back in place: they cross them or follow them very closely. It is impossible for the police to be unaware that this liberation of illegally occupied land objectively lasted only a few seconds...





In conclusion, a thumbing of the nose of fate saved three palettes: Next to the hospital, on 9th February, the dump truck was bogged down... It's a great opportunity, surreptitiously, to get three of them back...

For morale, not so ridiculous!

LIFE IN THE CALAIS CAMPS

Let us not forget that encampments are increasingly threatened. Tents under bridges are systematically removed.



When they are made sacred by railings, the exiles often manage to settle there anyway, but the narrow passages through which they enter are those that the Forces of Order also use to dislodge them, and these spaces become mousetraps...





Under the bridges, the town hall has accumulated obstacles to the installation of shelters, which are the most sought-after since, by definition they protect from bad weather: both grids and riprap limit the space still offered for the installation of tents.

The photos were taken under the Mollien Bridge, and next to it, on 25th and 27th February:

In 2019, the Abbé Pierre Foundation launched the "Pics d'Or" challenge, which rewarded (satirically of course) the worst anti-homeless devices installed throughout France and abroad. "*Calais, the international capital of the Wall and barbed wire!!* Jean-Claude Lenoir wrote on 10th February 2019. In order not to have been ranked, Calais must have been judged to be out of competition!!

On 27th February 2024, the Human Rights Observers (HRO) reported that a CRS officer found it very funny that they had said that an encampment was a place to live. One of his colleagues tells him it's a doormat, as he wipes his shoes in the grass. Of course, coming from a police officer, this is a shockingly contemptuous statement... But I must admit that I have never been able to read or hear the expression "living space" without being shocked, even if I have used it myself... It's not a place to live! In the mud, garbage, no toilets, no running water...

At best, you could say that it's a place of survival, maybe even a place of waiting for passage...

And yet, in the random videos of the HRO, we catch small moments of life, small things that are related to our daily life as well-to-do:

- wood sheds (photographed on 15th February)...



Laundry drying (photo of 13th February)





and even a dining room, with chairs set up around a kitchen fire! (also photo from 13th February).

All these photos were taken at BMX...

Is this a coincidence, or is there a special status for this corner of the earth? And what? It was also at BMX that a convertible sofa was seized on 29th February, notes the Human Rights Observers (HRO)!

THE GREAT MEN

THE MEN OF THE MONTH, WHO INSPIRE US.

ABBÉ PIERRE.

70 years ago, on 1st February 1954, Abbé Pierre launched his now famous appeal, which began with these words: "My friends, help... A woman has just frozen, last night at three o'clock, on the pavement of the Boulevard Sébastopol, clutching the paper with which, the day before yesterday, she had been expelled with. »

On 1st February 2024, commemorations multiplied everywhere, especially in Calais. A moving ceremony was held on the beach, with roses planted in the sand,



and banners. The one that quotes our Minister of the Interior was not the least noticed:





Among the speeches, that of our president, Jean-Claude Lenoir:



That morning, companions from several cities in France gathered at the local of Salam, rue des Fontinettes...



... before leaving around 9 am for a big food distribution.
500 people on Judea Street were clothed, equipped with clothes and blankets.
Two large trucks were emptied.
The guys were happy .

MISSAK MANOUKIAN.

80 years ago, on 21st February, 1944, Missak Manouchian was shot by the Germans at Mont Valérien, as a terrorist, along with 21 comrades.

"*Happiness! to those who will outlive us and taste the sweetness of tomorrow's Freedom and Peace*," he wrote in his last letter to his wife Mélinée, on the day of his death.

It is up to us, with our small means put together, to contribute, against the rise of the extreme right, to maintain in France the Freedom and Peace that we all need so much.

ROBERT BADINTER.

On 9th February 2024, Robert Badinter passed away at the age of 95. He will go down in history for having in 1981, as keeper of the seals, passed the law that abolished the death penalty in France..

But he was first and foremost a defender of all human rights. "On the very day of his death, the International Federation for Human Rights (FIDH) pays tribute to the memory of Robert Badinter, an uncompromising defender of human rights in their universality, an opponent of all rights violations, abuses and injustices." FIDH, 9th February 2024.

On 12th September 2015, at the microphone of Europe 1, in the midst of the migration crisis, he said: "When the Republic has failed in the right of asylum, it has always disgraced itself..." then "welcoming refugees is not an act of generosity, it is an international obligation for France".

FRENCH STANDARDS FOR ACCESS TO WATER

"Whoever you are, wherever you are, having access to water is one of your fundamental rights. Yet, even today, water scarcity affects more than 40% of the world's population."

NO, it is not "Solidarité Internationale" (humanitarian aid association for the most deprived) that publishes these lines, but the French government...

It also reads:

"Not having access to water is not just about being thirsty. It is also an issue of dignity, hygiene, health, agriculture, food security, educational success, poverty, sustainable development, but also gender, geographical and economic inequalities. »

Thanks to Arnaud, a volunteer at Salam du samedi, who found this document and adds:

"A page from the environmental code nicely completes this first document: And after research, I got my hands on the text below: it applies to establishments open to the public from the ^{3rd} category, i.e. those welcoming more than 300 people: Auchan, Pôle Marine, Centre Marine... »

It reads:

"For the purposes of the fourteenth paragraph of paragraph III of Article L. 541-15-10, "drinking water fountain" means any drinking water distribution device, connected to a drinking water network, allowing the filling of a beverage container.

The number of drinking fountains available to the public is adapted to the capacity of the establishment. This number is at least one drinking fountain for establishments that can accommodate 301 people simultaneously. It is increased by one drinking water fountain for every additional 300 people.

These drinking water fountains are indicated by visible signage, and their access is free of charge. »

In accordance with Article 7(1) of Decree No. 2020-1724 of 28 December 2020, these provisions enter into force on 1 January 2022.

Okay, maybe a migrant camp isn't strictly speaking a "settlement"... But who can argue that it is not a place, if not welcoming, at least that welcomes more than 300 people, often more than 600, often even much more...

TENTS AND TARPAULINS!

From dismantling to dismantling, the tents are removed at both sites, and we are unable to replace them. Many people sleep with nothing on them, in all weathers.

You can also buy tarpaulins, pieces of 3 m by 3 m (or 2.50 m by 3 m). They cost much less and allow an honest man to spend a night under cover.

Otherwise, the most pressing needs at both sites:

BLANKETS (DUVETS, SLEEPING BAGS).

men's clothing from XS to XL: underpants, long underpants and thermal leggings and thermal sweaters, socks, jogging pants, jeans, shorts, t-shirts, SHOES for men: trainers or light hiking shoes (sizes 40 to 46), flip/flops, sandles, caps.

backpacks, lamps and batteries, water packs, Bags (small backpacks, garbage bags, freezer bags, shopping bags and plastic bags)

Foodstuffs for Calais:

JAM, Milk tea and sugar, instant coffee, biscuits (or pastries, or cake bars or cakes etc...)

And for Grande-Synthe:

Mostly canned vegetables of all kinds (we have been getting a lot less fresh items lately), bags of pulses,


